REGULATIONS

MEMBERSHIP

Membership in Limestone Trout Club is on an annual, individual basis. A member's family is welcomed at Limestone when accompanied by the member and has unlimited guest visit privileges. New members are required to complete a 2 hour orientation session with the Property Caretaker (Jesse Nivolo) prior to fishing LTC water.

MEMBERSHIP CARDS

A Season Membership Card with lock combinations is issued to members in good standing and have a signed waiver form on record. Codes should not be divulged to anyone other than members.

LTC DAILY USE SIGN IN

All members **MUST** sign the log book in the clubhouse upon arrival. All guests must be entered by the member in the log book and wear a guest badge. See **BADGE SYSTEM** section. **First-time guests must sign a waiver form** located at the sign-in desk or at the Cottage.

HOURS

The Club property is available to members 24 hours a day. The last member leaving the grounds at night should ensure the Main gate is closed and locked.

GUESTS

A member may have any number of guests per day for cook-outs, picnics, and other general uses of the grounds. A member may host a maximum of three (3) guests fishing per day. **Non-family guests may only be invited to fish three visits per season.** For special requests or exceptions, contact one of the Club Officers or a Board member.

Guests who arrive at LTC prior to the member may proceed to the clubhouse if the gate is unlocked. Guests are not allowed to fish or use other club facilities until after properly signed into the Log Book by the hosting member. Members are **required** to stay with their badged fishing guests so they are aware of fishing best practices followed at LTC.

Pellets, Feeding and Chumming

Pellets, Feeding and chumming are prohibited

- ◆ The club schedules regular pellet feeding times for our trout to increase their size and overall health.
- ◆ Only authorized members of the fisheries committee or property caretaker are permitted to feed our trout. Do not add fish feed or chum the waters of our ponds.
- ◆ The club prohibits the use of "fish pellet" fly imitations or live bait (see **EXCEPTIONS**).

HARVESTING FISH

Catch and Release tactics are encouraged, but not mandated. A maximum of **2 fish//member/day** and **1 fish/guest/day** may be harvested.

No Tiger and Golden trout, regardless of size, shall be harvested unless the fish will not survive a release.

NO trout 20" or longer shall be harvested.

GUIDELINES

ANGLER'S GUIDE

Limestone Trout Club is a sportsmen's club devoted to providing our anglers and guests with the longest season and the best stillwater fly fishing experience. The Club is open for fishing from April 1 to December 31, conditions permitting. Boats are available on Birch and Pine until approximately Dec. 1; non-club boats/kayaks/float tubes are not permitted. Fishing may continue from the shore until the club closes. See **limestone-trout-club.com** for updates on latest status and conditions.

Stillwater fishing requires some different skills than those used in streams. Current conditions and fly suggestions are posted at the clubhouse, but success depends on proper presentation. See *Fishing at Limestone* under the Useful Documents webpage to learn more.

HANDLING AND RELEASING FISH

Fishing nets are provided throughout the club for all anglers to use. Please return nets to the location they originated from so the next angler can use them.

Here are some suggestions to minimally impact released fish:

- ◆ Fish barbless hooks or crimp your barb to minimize injury.
- ◆ Try not to fight fish to exhaustion, especially when warmer water temperatures exist.
- ◆ Wet your hands before holding fish.
- ◆ Minimize the time fish are out of water.
- ◆ Use a wet net and never lay fish on the ground.
- ◆ Assist fish recovery yourself until they can swim away.
- ◆ In warm weather, release fish where they have easy access to deep water.

FISHING CENSUS SHEETS

All harvested and released fish shall be recorded. Fishing Census sheets for both members and guests are available at the sign-in desk, the cleaning room, and the Cottage. Census info for both fish and flies used provides valuable information for fishery and facilities management—everyone benefits.

EXCEPTIONS

Children age 9 and under may fish **Spruce, Rock, and Club** using conventional fishing gear (spinning, casting, and push button reels). A worm and bobber may also be used.

BADGE SYSTEM

The Club has a badge system for member/guest recognition and to discourage unauthorized access (poaching). Badges are located in a wall rack to the left of the main clubhouse door. Members should wear their own badge and Guests should use a guest badge while at LTC. All Badges should be returned to the badge rack before leaving the property.

CLUB MEMBERSHIP

Membership brings together a diverse group of people with a common love of fishing and the environment, and it is critical to our financial health. If your guest is interested in finding out more about Limestone, have them fill in the contact information on the **Guest Census Sheet**. If you feel they would be good members, propose them for membership; contact our Membership Chairman for details.

CHILDREN

Children are welcome at LTC. Youngsters are to be supervised by a member, parent or adult when at LTC. Please insure they do not interfere with fishing rights and privacy of others while at LTC. A parent or guardian must sign a Liability waiver for children under their supervision.

With the right guidance, they will become the next generation of fly anglers, gain an appreciation for the outdoors, and become the stewards of our trout waters and those beyond.

PARKING

Members and their guests should park only in designated areas. Parking in the workshop areas near the entrance to Cedar Pond is limited. Do not park in front of the garage or open shed. When the grounds are soft and wet, drive only on established roadways and parking areas.

CAMPING

No active camping is permitted—trailers, tents, etc. at LTC.

DOGS

Dogs are welcome at the Club but must be kept under control. Dogs must not disturb members and should never be allowed in Club ponds. Cleaning up after the dog is mandatory.

SWIMMING

Swimming not allowed in any of the LTC ponds.

FIREARMS & FIREWORKS

The discharge of guns (including air rifles) and use of fireworks of any kind are not permitted on Club property.

SOCIAL MEDIA

The club has limited, direct social media presence. Public Ads, our website and word of mouth are the primary drivers for membership. LTC asks that photos and video taken on the property be limited to your personal use only and not posted or widely distributed.

FIRES

Fire is our greatest hazard and could spell disaster to our Club. Use the firepits/grills provided by the Club. Care and attention in the use of fires must be rigidly observed. You are responsible for fires you start!

**NEVER DISCARD CIGAR OR CIGARETTE BUTTS
IN THE PONDS OR ON THE GROUNDS.**

PROPERTY & MAINTENANCE

Care and maintenance of our property and grounds is everyone's responsibility. If you see something wrong, correct it if you can. If you cannot correct the problem, notify the Property Caretaker, the appropriate Committee Chair, or a Board Member. If you see litter, pick it up. Return club provided nets to the locations they originated from so the next angler has one. Suggestions on how to improve the Limestone experience are always welcome.

BOATS AND BOATING REGULATIONS

Boats, oars, and flotation devices are provided by the Club. After use, oars and safety equipment must be removed from the boats and returned to the storage sheds. Connecticut regulations pertaining to use of personal flotation devices (PFD) must be observed.

**NO WATERCRAFT OTHER THAN THOSE PROVIDED
BY THE CLUB ARE ALLOWED IN ANY POND.
BOATS ARE NOT ALLOWED IN BIRCH LAGOON.**

SUSPENSION OR FORFEITURE OF MEMBERSHIP

A membership is subject to suspension and/or forfeiture for conduct prejudicial to Limestone Trout Club after a proper hearing before the Board of Directors, as provided in the Club Bylaws.

Members with payments in arrears for more than 90 days are not "members in good standing" and are subject to suspension of club privileges until unpaid fees have been paid.

CLUBHOUSE BEVERAGES

We have an honor system for paying for the Keurig coffee machine pods and keeping the refrigerator filled with beverages. Please use the cash box for your deposits.

CEDAR COTTAGE RENTAL

Cedar Cottage is available to Limestone members and their guests from April to the end of **December**, weather permitting. We encourage all Limestone members to experience Cedar Cottage.

From 2/1 to 3/31, FULLY PAID UP stockholder members may reserve the cottage for a maximum of three(3) nights. Starting 4/1, all membership categories, who have fully paid their dues may reserve the cottage for unlimited nights.

Reservations are first come, first served.

Online reservations can be made on our website (preferred) **limestonetroutclub.com**. Website registration is **REQUIRED** for online reservations.

If you cannot use the website, please call member Steve van Fleet to make cottage reservations.

The rate for Cedar Cottage is \$125/night+15% tax

Because of limitations with the septic system, we ask that no more than six people occupy Cedar Cottage overnight.

CHECK OUT TIME IS 11:00AM

CHECK IN TIME IS 3:00PM

The cottage and firepit are for the use of those renting the cottage. Those in the cottage do not have exclusive rights to any specific fishing spots on Cedar Pond. However, when the cottage is occupied, other members are encouraged to refrain from fishing in front of the cottage until 8 AM.

Payment will be billed upon securing your reservation and is non-refundable. If you are unable to use your reservation, inform the Property Caretaker. You will be reimbursed for any re-rented days and if not re-rented, you will be credited with unused days to use at a later date.

Members and guests must sign in at the clubhouse and fill out daily census sheets.

Members reserving the cottage are responsible to leave the cottage clean and presentable for the next occupant. If any special cleaning is needed after a stay, the member will be

billed for the cleaning costs. A cottage use form is located in the cottage for check-out procedures and must be completed and signed before vacating.

CLUBHOUSE

LTC has renovated the clubhouse in 2024. All members are welcome to use the kitchen and dining areas, but please clean up and leave “no trace”.

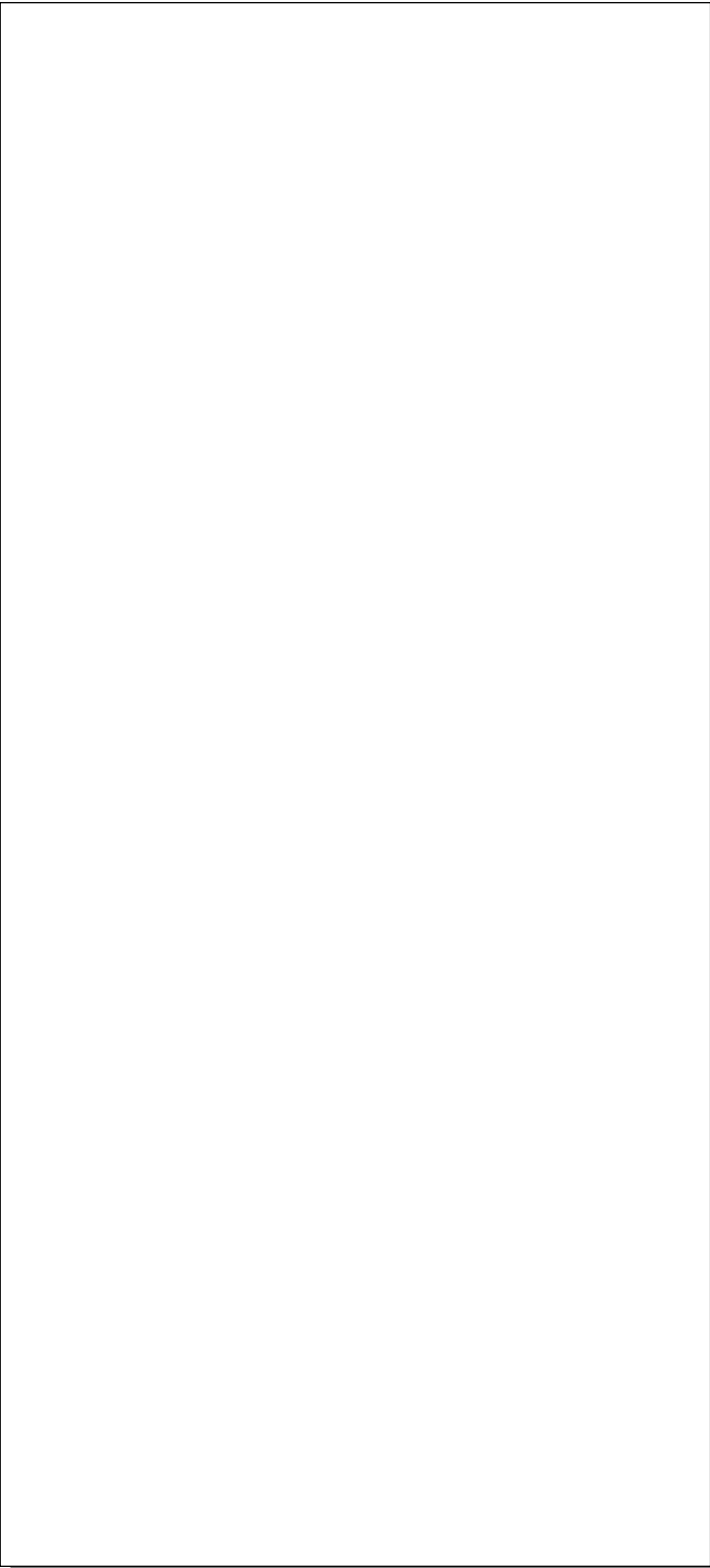
